Training Course Descriptions

AMERICAN RED CROSS CPR/FIRST AID/AED CERTIFICATION

This is the American Red Cross basic-level First Aid, CPR, and AED course. The purpose of the program for the lay responder is to provide participants with the knowledge and skills necessary to help sustain life and minimize the consequences of injury or sudden illness until advanced medical help arrives.

This is the pre-requisite for the American Red Cross Train-the-Trainer course immediately following the class.

AMERICAN RED CROSS CPR/AED/FIRST AID TRAIN-THE-TRAINER

Topics include characteristics required of an American Red Cross representative and role model; applicable first aid, CPR and AED skills at an appropriate skill level; ensure participants' health and safety during training; how to maintain complete and accurate records and reports; and plan, organize and conduct the first aid, CPR and AED courses in accordance with the requirements of the specific class the trainer will be teaching.

OSHA 2264 PERMIT-REQUIRED CONFINED SPACE OPEN TO IUOE INSTRUCTORS ONLY

AUTHORIZES INSTRUCTOR TO TEACH: Permit-required confined space as a standalone course or as part of other courses, such as HAZWOPER.

Technical topics include the recognition of confined space hazards, basic information about instrumentation used to evaluate atmospheric hazards, and ventilation techniques.
